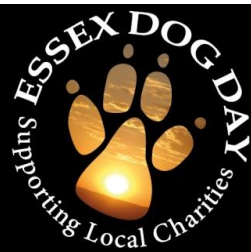

## CHARITY / CLUB TERMS AND CONDITIONS FOR THE EVENT:

1. Essex Dog Day is open to the public on Sunday 25<sup>th</sup> August 2019 from 10.00am until 5.00pm.
2. All trade/exhibition units must register their stall and set up on Sunday 25<sup>th</sup> August 2019 between 7.30am and 9.00am. Late arrivals may be refused entry with no refund.
3. The organisers carry Public Liability Insurance in respect of their own activities but all trade/exhibition units are responsible for theft or damage to their own units/goods.
4. All trade/exhibition units must have their own Public and Product Liability Insurance. At the time of booking a valid insurance certificate must be included with the application form for approval by the organisers. No person or organisation will be permitted to trade or operate at Essex Dog Day without valid insurance.
5. All trade/exhibition units and people working with or for them, participate in the event at their own risk and the trade/exhibition unit indemnifies the organisers against any loss of damage that any of them may suffer.
6. All trade/exhibition units will ensure that their unit is manned by trained personnel for the duration of the event.
7. Trade/exhibition units are permitted to park their vehicles on their pitch providing it **does not exceed** the area they have booked.
8. Cover is not provided (gazebos or marquee) with any pitches.
9. When booking pitches please remember to include for all guy ropes to marquees and tow bars etc. to ensure they fit on the allocated space.
10. Electricity will not be supplied; please supply your own generator should you require electricity.
11. Vehicle movement is not permitted between 10am and 5.00pm apart from service vehicles. Trade/exhibition units are not permitted to move vehicles or granted access to the exhibition area until 5.00pm.
12. No trade/exhibition unit to be dismantled before the end of trading at 5.00pm on Sunday 25<sup>th</sup> August 2019.
13. Stall holders are asked to keep their surrounding area as clean as possible throughout the time of the Essex Dog Day and to dispose of rubbish in the designated refuse areas. **Stall holders that fail to dispose of or remove all their rubbish will be charged £50.**
14. All trade/exhibition units to inform the Essex Dog Day Committee of the range of products to be sold to monitor clashes with other stalls.
15. Trade/exhibition units are **NOT** permitted to sell food or drink products for consumption on the day e.g. sandwiches.
16. We regret refunds will not be given for bookings cancelled by stall holders.
17. If banner space is booked with this application, you will be required to supply the banner before the event opens in order for it to be displayed correctly.
18. By applying for a site space stand you are agreeing to the above terms and conditions.
